1. Four (4) original duly-accomplished Dual Citizenship application form, typed or printed legibly in black or blue ink;
2. Original and Four (4) photocopies of Philippine Birth Certificate duly authenticated by the Philippine Statistics Authority and Department of Foreign Affairs;
3. Original and Four (4) photocopies of Philippine Passport;
4. Original and Four (4) photocopies of Foreign Passport, DNI/Cedula;
5. For Married Women, Original and Four (4) photocopies of Marriage Contract with English Translation duly legalized by the Foreign Ministry of the country where the marriage took place (IMPORTANT: valid only for marriages solemnized in Argentina, Bolivia, Paraguay and Uruguay. If marriage has taken place in a country other than the four stated above, the marriage contract should be authenticated by the Philippine Embassy in that country);
6. Original and Four (4) photocopies of Certificate of Naturalization with English Translation authenticated by the Ministry of Foreign Affairs;
7. Six (6) colored photos, 2" x 2", taken within six months before the date of application, showing a clear front view of applicant's face, with a royal blue background pasted in the designated box in the application form. No sleeveless attire. Blurred or low quality photos are not accepted;
8. Processing fee of \$50.00 payable in cash and in US dollars only.

FOR MINOR CHILDREN (below 18 years) INCLUDED IN THE PETITION

1. Six (6) colored photos, 2" x 2", taken within six months before the date of application, showing a clear front view of applicant's face, with a royal blue background. No sleeveless attire. Blurred or low quality photos are not accepted;
